



NORTH COUNTY DANCEARTS, INC. PAYMENT BY AUTOMATIC DEBIT/CREDIT CARD CHARGE AUTHORIZATION FORM

I hereby acknowledge that I agree to and authorize my bank to honor payments drawn by **North County DanceArts, Inc.** against my credit or debit card on account for fees as listed to include but not limited to contracted registration fees, tuition payments in full and/or monthly installment payments, merchandise and any unpaid outstanding balances on my account as per the agreed contractual notes listed below. This authority is to remain in effect until revoked by in writing in the form of NCDA's Notification of Termination Form to North County DanceArts, Inc. Notice of Termination must be received by North County DanceArts, Inc. no less than 30 days prior to the 27th day of the calendar month (scheduled automatic payment withdrawal) and on or before April 3rd of any calendar year to avoid terminating in the last quarter of the NCDA school year. I also understand that a fee of \$20.00 per incident will be charged to my account for reasons such as insufficient funds or credit card charge revocation and I agree to reconcile any outstanding balances due to such incidents within a five (5) day period from time of incident reporting by financial institution.

Please Note:

Tuition for classes at North County DanceArts, Inc. is an Annual Tuition policy (From September through July). Tuition may be paid in full by cash or check at time of student registration and enrollment from September through December at an approximate 15% savings; by debit or credit card for an approximate 7% savings or on a monthly automatic installment payment system amortized over eleven (11) months.

The NCDA annual tuition is a long term payment policy. Students electing to pay in monthly automatic installments must continue to pay monthly for the remainder of the dance year contracted payments (September through July). Students wishing to discontinue dance instruction during the year may do so by notifying North County DanceArts, Inc. in writing in the form of NCDA's Notice to Terminate Form no less than 30 days prior to the 27th of any calendar month, and before April 3rd in any calendar year to avoid terminating instruction in the last quarter of the dance year (May through July), thereby releasing the student from further tuition obligations. Students are responsible for the balance of the annual tuition contract if discontinuing services in the last quarter (May, June, July) of our dance year and all outstanding balances will become immediately due and billed against credit/debit cards on file.

For students electing to discontinue dance instruction and thereby declaring an early termination of the annual tuition contract prior to the final scheduled automatic payment (July) in and dance year, it is assumed that the student will not be returning to NCDA for dance instruction. Any student returning to NCDA after early termination of an annual contract in any dance year will be obligated to 'pay out' prior contract terms before enrolling in any NCDA studio class.

Students registering for classes after April 3rd will be required to pre-pay tuition for balance through July or agree to be placed on automatic payment for tuition installations due between April 3rd and July 30th. No 30 Day Notice to Terminate will be accepted during this time.

With my signature (18 years or responsible parent/guardian) I acknowledge that I have downloaded, read, understand, and agree to the General Policies, Tuition Rates and Policies (located at www.northcountydancearts.com) and the stipulations of the Automatic Debit/Credit Authorization of North County DanceArts, Inc. as noted above.
