

2020 RECITAL PARTICIPATION AND RECITAL FEE FORM

NORTH COUNTY DANCEARTS anticipates holding our annual dance recital at the Torrey Pines High School Performing Arts Center located at 3710 Del Mar Heights Road. We anticipate three (3) shows; an evening performance at 7:00 pm on Friday, July 24th and Saturday July 25th with a matinee at 12:00 noon and our last evening performance at 7:00 p.m. All three performances are approximately 1 ½ hours in length without an intermission.

North County DanceArts charges each performer recital fee for all participants dancing in our annual recital to cover the cost of specialized liability insurance required by each venue.

The annual dance recital is NOT MANDATORY, but a choice. We understand there may be many reasons why a student may choose NOT to participate in the annual recital and we encourage you to consider carefully all costs and requirements of the recital PRIOR to paying a recital fee or ordering a recital costume (please refer to your copy of the 2020 Dance Recital Information and Requirements documents or view them at www.northcountydancearts.com/news . ALL RECITAL FEES AND COSTUME FEES ARE NON-REFUNDABLE.

The Torrey Pines High School Performing Arts Center's house only seats 375 patrons per show. Each year we remind everyone that **all shows will SELL OUT** within the first weeks that tickets become available. **All shows are sold on a "First come, first served" basis.** For that reason, **NORTH COUNTY DANCEARTS cannot guarantee** any student, parent, family member(s), or friend's **tickets** to the annual dance recital, even if a recital participation fee has been paid or costume purchased. We encourage you to check your calendars (also provided on www.northcountydancearts.com/recital) for ticket sales date and do not hesitate when planning to purchase your tickets. **RECITAL FEES AND COSTUME FEES ARE NON-REFUNDABLE, even in the situation where a student, parent, family member or friend has not acted quickly to procure tickets to the show.**

Costume orders paid by cash, check or credit cards are being accepted as of Tuesday, January 21st in studio and by credit card online. We will continue accepting orders until February 22nd. For your student's costume to be ordered on time for the recital, payment of the **\$30.00 RECITAL FEE** must be paid on or prior to February 22nd. Any costume order received without the per performer recital fee **WILL NOT** be ordered.

NO COSTUME ORDER WILL BE ACCEPTED WITHOUT THIS ACKNOWLEDGEMENT OR PAYMENT OF THE \$30.00 PER PERFORMER RECITAL FEE.**

When remitting your recital fee, please pay by separate check to NORTH COUNTY DANCEARTS, INC. and note "Recital Fee" and performers name in the memo area of your check. More than one performer's recital fee may be paid per check. **PLEASE DO NOT INCLUDE RECITAL FEE ON THE SAME CHECK AS COSTUME FEES OR REGULAR CLASS TUITION PAYMENTS.**
